Paralegal

This paralegal program is nationally recognized by the American Association for Paralegal Education (AAfPE) and has a chapter of Lambda Epsilon Chi—the Paralegal Honor Society. Law-related courses provide students with a variety of skills in preparation for employment in the legal field, or for transfer to a four-year university.

Paralegal A.A.S. Degree

The Paralegal A.A.S. program combines general education courses with specialized law courses to provide students with a wide variety of knowledge and skills. Students who complete the program will receive an A.A.S. degree, and while the primary goal of this program is to prepare students for employment in the legal field, course credits may also be transferred to a four-year college or university to pursue a bachelor's degree.

Learning Outcomes

- Apply basic legal concepts and fundamental principles of law for varied legal tasks.
- Recognize a legal dispute, gather facts, and perform legal analysis for varied legal matters.
- Conduct client interviews and prepare witnesses and evidence for presentation at legal proceedings.
- Perform legal research and utilize techniques of legal writing in the preparation of legal documents.
- Demonstrate conduct consistent with the ethical obligations of the legal profession to avoid ethical violations.

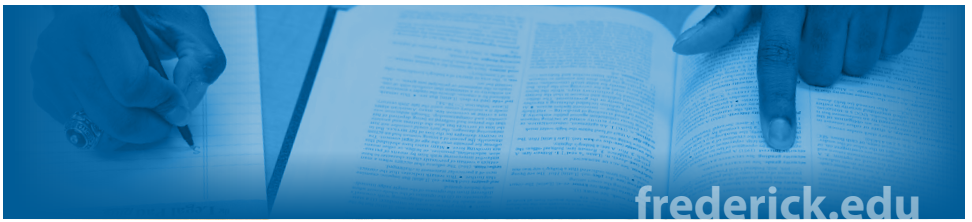
Paralegal Certificate

The Paralegal Certificate program is designed for individuals already in this field of employment who wish to increase their opportunities by acquiring college credentials. In addition, individuals who already have a degree in another field may be able to improve their employment opportunities through this program. This certificate program offers a condensed curriculum consisting of law-related courses.

Access to Justice Letter of Recognition

The Access to Justice Letter of Recognition program develops paralegals qualified to perform legal services under supervision to assist self-help center, private pro bono, or limited scope attorneys and promotes access to justice for low- and moderate-income people in crisis. This program offers specialized training that incorporates field placement to connect trained paralegals with legal professionals offering no-cost/low-cost services.

A drug screening and/or criminal background check is often required to obtain and maintain employment in this career field. Individuals whose criminal histories may interfere with their ability to secure employment should discuss any questions with FCC faculty.



Pre-Law

Paralegal programs may be used for students interested in law school. The FCC Paralegal Program curriculum covers the same substantive and procedural courses offered at law schools. Legal analysis (critical thinking), writing, technology, ethics and professionalism are infused into all legal specialty classes. The program manager, a full-time faculty member, serves as a pre-law advisor and assists students with law school applications.

Paralegal Student Association

As a student enrolled in the FCC Paralegal Program, you are invited to join one of the most active student organizations on campus. The purpose of the association is to encourage students to obtain a degree/certificate in the legal field and to foster relationships between students and the legal community. The association collaborates with community partners to provide free legal clinics on Pro Bono Day.

Internships help students integrate what is taught in the classroom with what is required in the workplace. Students take internships to develop knowledge and skills valued by employers. Students in the FCC Paralegal Program are eligible to receive credit for internships.
