- 1. <u>Apply to the College</u>: Apply to FCC and declare Pre-Health Professions Respiratory Care AAS as your major.
- 2. <u>Submit Official Transcripts</u>: Send official college/university and high school transcripts, SAT & ACT scores as well as any CLEP, IB or AP scores to the Records and Registration Office. Note that official college/university transcripts should be sent upon application to FCC, and must be received by application due date for Respiratory Care clinical program
- 3. <u>Apply for Financial Aid</u>: Apply for Financial Assistance Submit the FAFSA and apply for scholarships.
- 4. <u>Complete Placement Tests</u>: Complete FCC placement tests as needed Consult with Admissions or Advising.
- 5. <u>Complete Pre-Admission Courses</u>: Complete the following minimum requirement with a grade of C or higher*

Science Prerequisite BSCI55, BSCI150, or CHEM101 (recommended) Anatomy & Physiology I BSCI201 or BI103

Completion of additional program requirements (see below) by the June 1st application deadline is highly recommended as this adds points to a student's application and makes the student more competitive for admission. All additional requirements listed below must be completed to earn Respiratory Care AAS degree. Additional requirements include*:

- 6. <u>Complete Job Shadowing:</u> Complete job shadowing and have shadowing supervisor submit verification email to <u>HealthSciencesAdmissions@frederick.edu</u> by June 1st application deadline. The verification email should only be sent to the previous email address. Using any additional email will not be accepted as proof of job shadowing. Proof of job shadowing from the shadowing supervisor is the only form of approved job shadowing time. You can apply to any hospital Respiratory Department to receive this credit. Please contact their education department to inquire about job shadowing requirements and admission process.
